

# General terms and conditions of the Livinfrance scholarship program

Version française - English version

## Article 1: Purpose

**EDEN INITIATIVE, a SAS** with share capital of **4,200** (four thousand two hundred) euros, registered with the Lille Trade and Companies Register under no. **812 904 928**, whose registered office is located at **165 Avenue de Bretagne Euratechnologies, 59000 Lille** (hereinafter: "**Eden Initiative**" or "**Organizing Company**"), operating the Livinfrance brand and websites, is organizing a **scholarship program** from March 1, 2024 at 00:00 a.m. to June 10, 2024 at 11:59 p.m. inclusive (French date and time prevailing), hereinafter: "Program": "**Program**".

The purpose of these rules (hereinafter referred to as the "**Rules**") is to define the rights and obligations of the Organizing Body and the scholarship candidates (hereinafter referred to as the "**Candidate(s)**").

## Article 2: Conditions of eligibility

To be eligible to apply for the Program, the Applicant must meet the following eligibility criteria:

- **Level of study:** All levels of higher education (as defined in article L612-1 of the French Education Code) are accepted.
- **Field of study:** All fields of study are accepted.
- **Age:** No age limit. Candidates under the age of 18 must provide proof of legal representation.
- **Nationality:** All nationalities are accepted, with the exception of French nationals.

- **Combination of grants:** Accepted
- **Institutions/training concerned :** Candidates must be able to prove acceptance into a French higher education program to be eligible. Only courses recognized by the French government are eligible.
- **Origin of applications:** Only applications submitted using the "[Livinfrance 2024 Scholarship Application](#)" form will be considered.
- **Duration of stay for studies:** Must be 3 months or more.
- **Additional conditions:** Candidates must have a personal user account on the [livin-france.com](#) platform in order to validate their application. *Please note that creating an account is free of charge and does not require any device or material that could discriminate against the Candidate.*

Each Candidate may submit **only one application** via the online application form.

In any event, all information provided in the application form must be accurate. **It is the Applicant's responsibility to guarantee the accuracy of the information provided within the framework of the Program.** Any application form filled in incorrectly, incompletely, or containing inaccurate information, will not be taken into account and will result in the invalidity of the application, at any stage of the selection process.

## Article 3: Selection process

### Application / Registration

Applications must be sent using the "**Livinfrance 2024 Scholarship Application**" form, available only at the following URL: [bourse.livin-france.com/formulaire-2023-2024](https://bourse.livin-france.com/formulaire-2023-2024).

Eden Initiative declines all responsibility in the event of phishing or identity theft (within the meaning of articles 313-1 and 226-4-1 of the French Penal Code) by third parties.

Applications sent by other means will not be considered and will be automatically rejected. Incomplete applications will also be rejected.

The Candidate must be able to provide proof of a personal account on the **livin-france.com** platform before June 10, 2024 in order to validate his/her application.

### **First selection of Candidates**

Information concerning the Candidate's academic, economic and social situation will be requested in order to make an **initial selection of Candidates**.

The Candidate is responsible for the accuracy of the information provided.

The initial selection will be made exclusively on the basis of this information, at the sole discretion of Eden Initiative. The files of the shortlisted Candidates will be presented to the jury to select the winners of the Program.

### **Selection of scholarship holders**

Scholarship holders are selected by an independent panel of international mobility experts.

In order to select the scholarship winners, a motivation questionnaire will be proposed, and only applications submitted via this form will be considered. Shortlisted candidates may attach additional documents to support their applications:

- Cover letter/video
- Letter of recommendation
- Transcripts for the last 3 years
- Any other supporting documents

**The questionnaire must be returned within 7 (seven) days of receipt of the validation e-mail for the second round.**

The jury will use a scale based on the following criteria to score the applications:

- Candidate's personal and professional project
- Relevance of the mobility project

- Quality of academic record
- Extra-curricular activities

The assessment of candidates according to this scale is left entirely to the discretion of jury members.

**The applications selected in this way constitute the final list of prizewinners.**

## **Article 4: Announcement of results**

The results of the scholarship winners will be announced through a live session made up of Livinfrance scholarship partners and international mobility players. It will be **broadcast on July 10, 2024**, and the link will be announced at a later date.

The date on which the winner(s) will be selected is given as an indication only. The Organizing Body may, at its sole discretion and without prior notice, modify the date, form and methods of publication of the announcement of the winners. In the event of modification, Candidates will be informed by the Organizing Body as soon as possible.

Each winner will receive an e-mail with details of how to receive the services and a link to make an appointment with a Livinfrance agent for the rest of the procedure.

They will have 15 days from receipt of the email to confirm their acceptance and confirm or communicate their full contact details in order to receive their prize.

The Organizing Body may not be held liable in the event of non-delivery of the e-mail announcing the prize as a result of an error in the e-mail address provided by the candidate on the entry form, a change in the candidate's contact details, or in the event of a failure of the access provider, a failure of the Internet network or for any other reason.

If the winner does not respond within 15 days of the announcement of his/her prize, he/she will be deemed to have purely and simply renounced his/her prize. The prize will not be awarded to the winner and cannot be claimed at a later date. It will be kept and will remain the property of the Organizing Company without any right to claim.

No transfer or deferral of the grant is possible.

Unsuccessful applicants will also be informed by e-mail.

## Article 5: Services provided

The value of the prize is determined at the time of writing. This prize may not be the subject of a request for financial consideration, exchange or return, for any reason whatsoever.

### Housing

Each winner will receive personalized assistance in finding a home, putting together a rental file and will be offered reservation fees for **participating Livinfrance homes** amounting to **€595** (maximum price recorded on Livinfrance reservation fees).

For winners who have already made a Livinfrance reservation, the reservation fees will be reimbursed in full, **exclusively on the payment method used**.

The start date of the rental contract must be **between 01/05/2024 and 31/12/2024**, and the rental period must be a **minimum of 3 (three) months in Lille and 8 (eight) months in other French cities**.

### Liability insurance

Each winner will receive a Livinfrance civil liability policy **worth €40** (maximum price).

The contract begins on **01/08/2024 and expires on 01/08/2024**.

### Housing certificate

Each winner will receive a housing certificate to help them apply for a student visa (if required), worth 99€.

The contract start date must be specified by the student, and must be **between 01/06/2024 and 31/12/2024**.

## Personalized support

Personalized support worth **€250** (maximum price) will be offered to each winner. A Livinfrance agent will be assigned to each winner to help with all administrative formalities (CVEC, CAF, French health insurance, visa validation and first application for a residence permit).

## Premium visa service (if required)

A Visa Premium support package worth **€149** will be offered to each winner. This package includes the France-Visas form, analysis of supporting documents and priority support for all visa-related procedures. A Livinfrance agent will be assigned to each winner to guide them through the process.

**Each winner will receive a complete package worth €1,000 for his or her study stay in France.**

## Article 6: Protection of personal data

In the context of the Program, the data collected and processed is strictly necessary for the proper execution of the Program, and is collected exclusively via the application form available at the following URL: [bourse.livin-france.com/formulaire-2023-2024](https://bourse.livin-france.com/formulaire-2023-2024). No other personal data will be collected.

The data collected and processed are strictly necessary for the following purposes:

No personal data is collected automatically. Candidates' personal data will be communicated exclusively to jury members by the Organizing Body. To this end, the Organizing Body and its jury members are responsible for maintaining the confidentiality of this data.

Candidates' personal data collected during the Program is kept for 1 year and is never sold to third parties.

In order to validate their application, Candidates will be invited to register on the [livin-france.com](https://www.livin-france.com) website, and on this occasion, to accept the [privacy policy of the livin-france.com website](#), separate from this one.

In accordance with the French Data Protection Act of January 6, 1978, as amended, and the General Data Protection Regulation (EU) 2016/679, you have the right to access, rectify and delete any data concerning you. You may request the portability of your data. You also have the right to object to the processing carried out or to request its limitation.
